- ATA has been recognized as a CompTIA Partner of the Year and has been named to the EC-Council's Academic Circle of Excellence for multiple years running.
- Have obtained a Provisional License from the Commissioner for Independent Education.
- The Commission for Independent Education has statutory responsibilities in matters relating to nonpublic, postsecondary, educational institutions. (Chapter 1005, Florida Statutes, The Rules (Chapter 6E, Florida Administrative Code)

SUBJECT: Eligible Training Provider List (ETPL) – Northwest Florida State College

INTRODUCTION

- Northwest Florida State College (NWFSC) was approved as a Continued Eligibility Training Provider at the CareerSource Okaloosa Walton Board meeting on August 5, 2020.
- An overview of the programs was briefed during the Business Competitiveness Council (BCC) meeting on July 30, 2020.

BACKGROUND

- In accordance with CareerSource Florida Administrative Policy Number 90, Effective March 1, 2016, Continued Eligibility Training Provider are approved for a two-year eligibility.
- Northwest Florida State College is requesting to add a Commercial Driver License (CDL)Training Program to ETPL for PY 2020-2021.
- Industry- recognized credential earned by completers: Yes.
- Wage range: \$13.16 (Entry) \$22.20 (Mean)

Updates:

Okaloosa Economic Development Council - Nathan Sparks announced that TeCMEN Industry Day has been postponed from Aug 28 to April 14, 2021. The event is sold out for 37 exhibitors and 13 sponsors, 95% said they would support the move. The website is available for updates. Shoal River Ranch is progressing. The Okaloosa Board of County Commissioners acquired 623 acres. Incentive review and approval by Okaloosa BCC and the Ft Walton Beach City Council is progressing for a defense contractor which will create 40+ jobs over the next three years. They are engaged in reconnaissance and surveillance technology and manufacturing and will be moving their U.S. headquarters from Washington D.C. metro area to FWB. Another

company focused on PPE will manufacture the material used in medical masks and gowns. They are one of only two U.S. manufacturers and will create about 40 jobs. They have a new on-line virtual entrepreneurial support incubator at www.startupokaloosa.com.

<u>Walton Economic Development Association</u> – Bill Imfeld said they have had success attracting new industry. A drone manufacturer is leaving Daytona Beach to relocate to the new industrial park on 331. An old plant on US 90 abandoned since 2002 has been sold to a Georgia company to use the rail siding to off-load ethanol.

<u>Okaloosa Schools</u> – April Branscome said Okaloosa Schools open Aug. 31st. A significant number of students will be on-line. Adjustments are being made and classrooms sanitized and prepared. A carpentry program is opening at Choctaw HS and Bruner MS and the focus next year will be FWB HS. David Johnson has left due to family reasons.

<u>Walton Schools</u> – Wyndy Crozier reported Walton Schools are opening Monday, Aug. 10th and teachers already returned. They are focused, excited and ready to go.

<u>Northwest Florida State College</u> – Bill Allison said NWFSC starts Monday, Aug 17th. They will have a large portion of coursework on-line to help maintain an on-campus presence. Academies, welding, heavy lab classes & medical programs will meet on-campus with safety precautions and social distancing. NWFSC was awarded the \$1.5 million DOL Apprenticeship Grant.

<u>Okaloosa Technical College</u> – Mendy Owens said OTC starts August 11th. OTC is working on a rapid credentials grant- tech support and cybersecurity classes (100% tuition and lab fee).

<u>University of West Florida</u> – Nicole Gislason shared that labs are open by appointment only. School starts on August 21st. Lectures will be held online. Nicole sent out information on the Haas Center's social media page. We are launching a statewide survey of small businesses.
